# ARTICULATION AGREEMENT BETWEEN BERKELEY COLLEGE AND MERCER COUNTY COMMUNITY COLLEGE

**AGREEMENT** by and between Berkeley College ("Berkeley"), an institution of higher education with a location at 44 Rifle Camp Road, Woodland Park, NJ 07424 and Mercer County Community College located at 1200 Old Trenton Rd, West Windsor Township, NJ, 08550 ("MCCC").

**WHEREAS**, the parties desire to facilitate opportunities for the full transfer of MCCC associate degrees towards a corresponding bachelor's degree program at Berkeley, subject to the terms and conditions below; and

NOW, THEREFORE, the parties agree as follows:

# I. DESCRIPTION

This Agreement applies to students who have graduated from MCCC with an associate's degree, apply for admission to Berkeley College, and wish to transfer credit earned at MCCC to a corresponding bachelor's degree program at Berkeley. Transfer credits will be applied toward the first two (2) years of the corresponding bachelor's degree program at Berkeley, provided that students meet the eligibility criteria outlined below.

#### **II. ELIGIBILITY**

Berkeley will accept transfer credits for students who meet the following criteria:

- A. Student has completed an Associate in Arts (AA), Associate in Science (AS), and/or Associate in Applied Science (AAS) degree at MCCC in a program that corresponds with a Berkeley bachelor's degree program;
- **B.** Student has taken all of the required courses to be applied toward the corresponding Berkeley bachelor's degree program listed in Appendix A, which is hereby incorporated into this Agreement by reference;
- C. Student has earned a passing grade or higher in all of the required courses listed in Appendix A;
- D. Student has applied and been admitted to Berkeley; and
- **E.** Student enrolled in a corresponding bachelor's degree program at Berkeley.

#### III. TERMS

- **A.** Berkeley shall have and retain sole discretion as to student admission and matriculation. MCCC students are not guaranteed admission to Berkeley College and their applications will be subject to review.
- **B.** If a student has completed a program at MCCC that is not included in Appendix A or does not otherwise meet the eligibility criteria outlined in this Agreement, the student may still submit his or her MCCC transcript for evaluation. Berkeley will evaluate the student's transcript in accordance with its Transfer Credit Policy.
- **C.** Certain healthcare programs at Berkeley College are subject to state and/or accrediting agency requirements and have specific transfer credit criteria. Students who do not satisfy the program transfer credit criteria may be required to re-take courses or take additional courses.

- **D.** In the event that either party modifies or eliminates its program and/or course requirements, it will make reasonable efforts to notify the other party prior to any implementation of any curricular changes that might affect this Agreement.
- **E.** The parties agree to make a good faith effort to update their respective program and course information on the New Jersey Transfer website.
- **F.** Grades earned at MCCC are not transferable and will not be applied toward the calculation of the student's grade point average earned at Berkeley.
- **G.** Not all degree programs and courses are offered at every Berkeley location. Students may be required to take some courses at another location or online.
- **H.** Berkeley reserves the right to add, discontinue or modify its academic, scholarship and other programs and policies at any time.

#### **IV. TERMINATION**

This Agreement shall remain in effect for 5 years from the date of the last signature below (the "Initial Term"). Following the Initial Term, the parties may elect to renew this agreement for an additional five (5) year term upon mutual written consent. Either party may terminate this Agreement by providing at least three (3) months' written notice prior to the intended date of termination.

# V. PROPRIETARY MARKS; PUBLICITY

Each party acknowledges that the other is the exclusive owner of certain trademarks and service marks ("Marks"). Each party agrees not to use the Marks of the other for any purpose without prior written consent. The parties hereby grant each other permission to refer to the names of the parties and this Agreement in each party's official Catalog and web site, and in other ways for the sole purpose of promoting the successful implementation of this Agreement and communicating its contents to the general public.

#### VI. INDEPENDENT CONTRACTORS

It is expressly understood that Berkeley and MCCC are independent contractors. Nothing herein shall create any joint venture, legal partnership, agency relationship or otherwise provide any authority of the one party to bind the other to any third party. Neither party may act in any way as the representative of the other, nor is either party authorized to incur any liability, obligation or expense on behalf of the other party.

## VII. ASSIGNMENT

Neither party shall assign or subcontract any portion of its rights or obligations under this Agreement to any unaffiliated person or entity without the written consent of the other party. Any attempt to do so shall be deemed null and void as between the parties. This Agreement shall be binding upon the parties' successors and permissible assigns.

#### VIII. GOVERNING LAW; VENUE

This Agreement shall be governed by the laws of the State of New Jersey without giving effect to any conflict of laws provisions. Any legal proceedings arising out of this Agreement shall be commenced and maintained exclusively in a state or federal court located in the State of New Jersey. The parties hereby consent to jurisdiction and waive any objections to venue in such courts.

#### IX. NOTICE

Notice shall be given to each party at the address listed below (i) by deposit with an overnight courier with charges prepaid; (ii) by deposit in the United States mail, first-class postage prepaid by registered or certified mail; or (iii) by email to the other party, which shall be effective upon the giving of a separate acknowledgement of receipt. Any notice shall be deemed to have been given one (1) business day after deposit with an overnight courier or three (3) days after deposit in the United States mail.

#### X. ENTIRE AGREEMENT; AMENDMENT

This Agreement constitutes the entire agreement and understanding between the parties relating to the subject matter it addresses and supersedes all other agreements, representations and understandings between the parties with respect thereto. Except as otherwise noted, this Agreement, including its appendices, may not be supplemented or modified without a written and dated amendment signed by both parties. Any amendments or modifications to the transfer tables in Appendix A may be evidenced by a written and dated amendments signed by both parties or confirmed by an exchange of electronic messages (e.g. e-mail).

#### **XI. MISCELLANEOUS**

- **A. Survival of Terms**. The provisions concerning intellectual property rights shall survive the termination of this Agreement.
- **B. Headings.** Headings set forth in this Agreement are intended solely for organizational purposes and shall not affect the interpretation of the underlying provisions.
- **C. Counterparts.** This Agreement may be executed in counterparts. Execution may be evidenced by an electronic copy (facsimile or electronic image) of the signed document.
- **D. Severability.** In the event a court of competent jurisdiction declares any provision of this Agreement to be void, the remaining provisions shall be deemed severed and shall remain enforceable to the full extent permitted by law.
- **E. Force Majeure.** Neither party shall be liable for a failure to perform its obligations under this Agreement to the extent that such performance was rendered impracticable by fire, flood, police action, public safety emergency, epidemic, natural disaster or act of terrorism or war.
- **F. No Third Party Beneficiaries.** Nothing in this Agreement, express or implied, is intended or shall confer upon any other person or entity, any enforceable right, benefit or remedy of any nature by reason of this Agreement.
