Attached is the updated TCNJ/MCCC Admission Articulation Agreement.

Mercer County Community College (MCCC) and The College of New Jersey (TCNJ) enter into this articulation agreement to help facilitate the seamless transition of students from MCCC to TCNJ.

Subject to the terms of this agreement, a student who completes an A.A. or A.S. degree from MCCC with the required grade point average (GPA) set by TCNJ and included in this document, satisfactorily completes the application for admission, and complies with all other pertinent admissions requirements (e.g., in good academic and disciplinary standing) will be granted admission to TCNJ.

In addition, MCCC students earning either an A.A.S. or A.F.A degree will be considered for TCNJ's School of the Arts and Communication. Students offered admission on this basis may, with diligence and proper planning (including accounting for Liberal Learning major course of study and other graduation requirements), complete the requirements for the baccalaureate degree program within two years of full-time study for the majority of TCNJ degree programs. In some cases, for some majors, this may require winter and or summer courses. For A.A.S. and A.F.A. degree-holders, and depending on the program, additional time may be required.

This agreement applies to students who plan to enroll at TCNJ for the *Fall 2023* semester and beyond. All parties at MCCC agree to the terms of this agreement.

In some cases, for some majors, this may require winter and or summer courses. For A.A.S. and A.F.A. degree-holders, and depending on the program, additional time may be required.

This agreement applies to students who plan to enroll at TCNJ for the Fall 2023 semester and beyond.

To be eligible for this agreement, the MCCC student must meet the following obligations:

• Students must graduate from MCCC with an A.A. or A.S. degree (an A.A.S. or A.F.A. degree will be considered for the School of the Arts and Communication) with a minimum GPA as outlined below. The following majors are included in this agreement:

• If the above GPAs and/or class requirements are not met, TCNJ will determine appropriate admission on an individual basis.

Obligations of TCNJ:

- To facilitate a smooth transition from MCCC to TCNJ for all students.
- Waive the application fee for eligible MCCC students who apply to TCNJ and meet the requirements of this articulation.
- To have a consistent presence on the MCCC campus to assist prospective students.

Obligations of MCCC:

- Publicize this agreement to prospective and current MCCC students.
- Arrange a regular (at least once per week) meeting location on the MCCC campus for a TCNJ transfer advisor to meet with prospective students.

Joint Obligations:

- A yearly meeting will be scheduled by TCNJ to implement and inform of changes in policy or curricula that directly affects students transferring under the terms of this agreement and keep each institution informed of any other changes in policy or curricula that affect those students.
- Each institution will identify a contact person or persons who will coordinate this agreement and communicate with each other on issues that may arise throughout the year.
- Facilitate and support consultation and collaboration between their faculties related to this and future agreements.

Revisions, Renewal, and Termination of this Agreement

This agreement will be in effect as of the date of its signing, for students entering TCNJ from MCCC on or after **August 2023**. It will be reviewed annually by appropriate parties at each institution and will be renewed automatically until superseded by a new agreement or formally terminated. Either institution may terminate this agreement at any time by written notice of at least one year in advance of the effective date of termination. Should this agreement be terminated it is understood that the termination will not apply to students already accepted to TCNJ.

The willingness of both institutions to enter this agreement in order to facilitate the transfer of students from MCCC to TCNJ and to expand their opportunities for academic success is indicated by the following signatures.
