The Board authorized the President to enter into an agreement with TIAA/CREF to permit eligible employees of the College to purchase retirement annuity benefits under the Supplemental Retirement Annuity option. Eligible employees are defined as those who are in the State Division of Pensions Alternate Benefit Program.
