Co- or Pre-requisites: ENG 102; permission of internship advisor Implementation Spring 2022

<u>Catalog description</u>: Liberal Arts program students in their last 30 credits gain practical experience in an approved social science or humanities-related setting outside of the college, guided by a faculty internship advisor. Interns demonstrate their ability to apply liberal arts concepts and objectives via employer evaluation, written self-evaluation, and discussion with advisor.

Units of study in detail – Unit Student Learning Outcomes:

Unit I: Introduction to the Internship (Supports Course SLO #1-3)

Learning Objectives

The student will be able to ...

- articulate clearly to the advisor the internship provider's expectations,
- find and understand the resources on the Blackboard course shell,
- review and articulate concepts and values from previous Liberal Arts coursework,
- speculate as to how those concepts and values may be applied to the internship experience, and
- demonstrate understanding of the need for balance between the internship and completion of other coursework.

<u>Unit II:</u> Applying Liberal Arts skills and thinking to the internship experience (Supports Course SLO #1-6)

Learning Objectives

The student will be able to...

- apply subject-area knowledge gained from study of Liberal Arts program coursework to field experience demonstrated through journaling, keeping a log, or discussions with advisor;
- evaluate a prospective career based on the internship experience;
- think critically about ethical situations that arise during the internship experience;
- apply research methods and critical thinking to the internship experience;
- adapt interpersonal skills learned through liberal arts coursework (collaborative learning, receptive listening, respect for difference, promptness) to the internship experience; and
- if possible, use world language skills to enhance performance.

Unit III: Self-Evaluation (Supports Course SLO #1-3)

Learning Objectives

The student will be able to ...

- create requirements (through discussion with the advisor) for the self-evaluation that fit the scope of the internship,
- evaluate personal growth, interpersonal awareness and experiential knowledge resulting from the internship experience, and
- view the internship experience through the lens of Liberal Arts methods and values.

Evaluation of student learning:

30% Online or onsite consultations with advisor will help the student continually reflect on how to apply Liberal Arts learning and values to the internship experience while it is taking place and articulate how the practical experience of the internship relates to the skills and critical approaches to problem solving gained in Liberal Arts coursework.

10% Written response to the internship experience (options: log, journal, notes, etc.) will help the student capture and remember reactions to incidents during the internship and see them as part of a larger experience. In the journals and notes, students will begin recording the connections between theory and practice that will culminate in the self-evaluation.

20% Final performance report from internship supervisor will provide the advisor with another point of reference on the student's growth, abilities to perform in a professional setting.

40% Self-Evaluation: written project articulating what a student has gained from the experience after the internship has ended: growth, insights and need for further growth. The student will demonstrate competence in all six course student learning outcomes in writing this self-evaluation.
