Pay Now Instructions

These instructions will walk you through the process of logging into your portal, going to the payment center, and filling out the payment information.

- 1. Go to mccc.edu and click MyMercer
- 2. Click on the Sign In button
- 3. Enter your username and password
- 4. Click "Pay Now"
- **5.** Click Make a Payment
- 6. Click Continue to Payment Center
- 7. Click Make Payment
- 8. Select the term you wish to pay for
 - **Click Continue**
- 9. Select the method with which you want to pay from the drop down menu

Fill out all relevant payment information, and click Continue when finished. As long as everything is correct, continue to select Continue/Make Payment until you are told the payment was successful.

A receipt will be sent to your student email, and you should be able to screenshot the final payment confirmation page. Make sure you proceed all the way through and make payment at the end; if you do not receive a receipt then you did not complete the payment.
