In addition to many exhibition monographs, Barros is also the author of *Facing Sculpture: A Portfolio of Portraits, Sculpture, and Related Ideas* featuring his portraits of sculptors and their work.

Awards

More than \$1,000 in prizes, including Best in Show, Juror's Merit, Honorable Mention, and Mercer County Purchase Awards, will be awarded.

Eligibility

Open to all artists, 18 years or older, currently living, attending school, or employed in Mercer County. All images created utilizing photographic processes, including black and white and color photography, non-silver processes, book art, and computer derived photography are eligible. Work must have been created within the past two years. All two- and three-dimensional work must be appropriately presented for gallery installation. Two-dimensional work must be framed and wired for hanging.

Entry Fee

Entry fee is \$20 for up to three entries per individual artist (cash or check made payable to Mercer County Community College). Entries must have the completed entry label (including sales price or insurance value if not for sale) securely attached to the back. The Gallery receives a 25% commission on all works sold. Work does not have to be for sale.

Entry Procedures

All work must be delivered by hand to The Gallery, CM Building, Mercer County Community College West Windsor campus on October 29 from 9:30 a.m. to noon. Work NOT selected for the exhibit must be picked up by 5 pm on October 29, no exceptions. Photographs selected for the exhibition will be insured against damage and theft while on exhibit at The Gallery. Work that has not been claimed by December 21 at 8 pm becomes the property of Mercer County Community College.
