



Missing Children: Dynamics & Response (MCDR)

MCDR is one day seminar, presented by the National Center for Missing & Exploited Children®, providing critical information to those call-takers, officers and investigators who will respond to a missing or sexually exploited child report and whose knowledge, skill and ability may make the difference between recovery and a protracted investigation.

This course is designed for telecommunicators, first responders, first-line supervisors, investigators, and command staff . The MCDR training is a key component of the Missing Kids Readiness Project.

Missing Kids Readiness Project

The Missing Kids Readiness Project promotes best practices for responding to calls of missing, abducted and sexually exploited children. Agencies will be recognized by the National Center for Missing & Exploited Children® for meeting essential training and policy elements demonstrating preparedness for responding to a missing child incident. Craig E. Hill ♦ Associate Director of Law Enforcement Training

After 35 years of service in law enforcement, Craig Hill retired as Deputy Chief of the Leawood, Kansas Police Department in September of 2005. In 1983, after working the abduction of a 10-year-old girl, Mr. Hill co-founded the Lost Child Network (LCN), a non-profit Child Resource Center in Kansas City. In 1998, LCN merged with the National Center for Missing & Exploited Children (NCMEC) becoming its 5th branch office (Kansas City Branch). Mr. Hill has spent over 28 years providing training and presenting lectures on the crimes committed against children to law enforcement agencies and numerous communities, colleges, universities, hospitals and Fortune 500 companies throughout the United States and parts of Canada. During his career, he has received numerous recognitions for his work on missing children cases, including the recovery of two kidnapped children from Kansas found 2 ½ years later in Arkansas; the recovery of a 12-year-old girl found in Florida six years after she was abducted by using an age-progressed photograph; and, the arrest and later conviction of a 29-year-old Connecticut man for the abduction and homicide of a teenage girl. Mr. Hill attended the first White House Conference on Missing, Exploited and Runaway Children in 2002 and was invited to the Rose Garden for the signing of The PROTECT Act of 2003. Mr. Hill is a graduate of the 8th Session of the FBI Law Enforcement Executive Development Program, the 203rd Session of the FBI Academy, and recipient of the 2007 FBI Director's Community Leadership Award. In November of 2005, after serving 10 years on the National Center for Missing & Exploited Children Board of Directors, he accepted a position as the Associate Director of Training & Outreach.
