

AVIATION PROGRAM REGISTRATION PROCESS *Aviation Flight Technology (not RTP)*

The Mercer County Community College Aviation program has specific enrollment requirements that must be met for registration. To begin the process, students must submit an Aviation Registration Request form for all AVI and CSA courses.

| New Students starting the program must hold a first or second-class FAA medical certificate from an Aviation Medical Examiner (AME). You'll be required to upload a copy (in PDF format only) when completing the form, or you may email the PDF copy from your student email account to <u>aviation@mccc.edu</u> along with your name and student ID. |
| New Students starting the program with a Private Pilot License (PPL), must submit a copy in PDF format only (no other format will be accepted). You can either upload the copy when completing the form or email the PDF copy from your student email account to <u>aviation@mccc.edu</u> along with your name and student ID. Students who transfer in their PPL, will need to take AVI-111 when offered. |
| US citizenship or TSA approval: All flight students must provide proof of US citizenship or TSA approval (for non-citizens). Non-US citizens seeking TSA approval for the college 141 program must ensure they select Mercer County Community College on the application form (do NOT use Infinity Flight). The TSA application link is: https://www.fts.tsa.dhs.gov/home . |
| ENG-101 and MAT-115 requisite: Students must have successfully completed ENG-101 and MAT-115, be awarded transfer credits, or be co-enrolled in these courses when starting aviation classes. Co-enrollment must be in the 14 week or 7A week session. | Register for general education requirements (non-aviation courses). Contact Academic Advisor Melissa Santiago at <a href="mailto:santiago.</td></tr><tr><td>GPA requirement: Students must maintain a grade point average (GPA) of 2.0 to remain on active flight status.</td></tr><tr><th>Continuing students who need to take AVI-241 and AVI-217 must instead register for AVI-270, as it is now a combined course. After you complete AVI-270, your Faculty Advisor will be required to process a course substitution to update your academic record.</th></tr><tr><td>Revised aviation registration request: Revised request replaces previous submissions entirely.</td></tr><tr><td>MILITARY & VETERAN STUDENTS: Students must receive clearance from the Military and Veteran Services office before registration. Contact vetservices@mccc.edu . |
