The following key points are important to remember when working in the clinical environment with a student veteran:

- 1. It is vital that student veterans are aware that his or her Clinical Instructor understands his/her needs.
- 2. Encourage student veterans to talk to you if they encounter any issues that influence their ability to meet the course objectives.
- 3. Expect the same performance from student veterans, but remain cognizant of absences related to Veteran Affairs medical appointments or reserve-duty obligations.
- 4. Do not assume that all student veterans deal with Post Traumatic Stress Disorder (PTSD).
- 5. Avoid placing a veteran in an uncomfortable position by asking them to share any military experiences or disclose opinions.
- 6. Historically, one of the most insensitive questions that a veteran may be asked is, "Did you kill anyone"? As the Clinical Instructor, if such a question is posed to your veteran student, it is important that you clarify that this is an inappropriate question and not acceptable in your facility.
- 7. Additional questions that are considered insensitive and inappropriate are: "Have you served overseas?" "Have you served?" "Where have you served?" These questions do not respect the student's privacy and it makes an inherent assumption that service to our country is only defined as oversea deployment.
